Sir.

This is with reference to your letter for me vide no. SM/35/30/2013 dt. 28.05.14 on the subject 'RTI Application in r/o Shri T.D. Banerjee, with which a copy of DST's 10-paged detailed letter No. SM/11/03/2011 dt. 09.05.14 to SG regarding Cadre Restructuring of SOI has been annexed since received by me at home on 12.06.14 i.e. on the day following that in which I have been released from Hospital after undergoing a major operation.

- 2. Of the DST's said letter to SG which has surprised me to a degree is that you have, despite lapse of such a lengthy time taken by the Secretariat, decided to undertake the C.R. Proposals in two parts i.e. Restructuring of the Organization and C.R. of Gp. 'A' Posts in the 1st phase while C.R. of Gps. 'B' & 'C' Posts in the next or 2nd phase. Moreover, it has been stated that considering some facts and circumstances it is proposed to delink the proposals of C.R. of Gps. 'B' & 'C' Posts and it has further been decided to appoint an expert group / committee for doing an in-depth study of Gps. 'B' & 'C' Posts in tune with the present-day need and advancement of technology etc. etc.
- 3. All these things / decisions coming under Para-2 of this letter, taken together, are being reasonably objected to in the sense that setting up of any further expert group or committee at this stage for so-called in-depth study after an abnormal wasteful of times for nearabout Eleven (11) long years from Dec. 2003 upto this 1st week of July, 2014 will be hardly of any use. The ministerial staff-members in general and their beloved Organization M.S.A. in particular have already had their bittermost experience as to what can be done by such expert group / committee as also as to how much more time they can take for exercising their study or process aimed at completion thereof, what to speak of implementation of the C.R. from back date i.e. due date. It is not at all graceful to note that the present DST Official to whom the responsibility had been fixed quite some years back is yet to make himself least capable of commencing that required
