**Sub: Immediate Implementation of abnormally long-pending CADRE RESTRUCTURING from its due date(i.e. 19th December, 2003) right at DST- level itself=Urge for.**

Ref: In continuation of my detailed & self-explanatory letter No. J-MSA/Svy./01/2017 dated 23-02-2017 for your kindness with a copy forwarded to each of the Hon'ble Cabinet Secretary to GOI & Respected SG amongst others.

Sir,

Kindly refer to the entire contents of my abovequoted very important letter on the subject issue (which was quite detailed & self-explanatory one in all respects) a copy of which is enclosed for favour of your kind information, ready reference and earliest implementation of the pretty long-overdue CADRE RESTRUCTURING from its due date keeping into active view that on one hand the very-much needed C.R. Implementation is yet to be done within more than long 14(fourteen) years from December, 2003 to date while on the other hand as many as 5 Hon'ble Secretaries to GOI, Min./Deptt. of Sc & Technology & 7/8 Surveyor Generals of India including the present one (whose date of superannuation will be 30th June, 2017) Shri S.Subbarao could hardly do anything but to simply come and go and take the roles of almost silent spectators over the most burning-cum-sensitive issue like C.R.. This is really Unique(!).

2. During the last 8-9 years i.e. from 2008-09 upto 2015-16 in particular it was being repeatedly told from the ends of the Administrative Higher-ups that the C.R. Issue had been under active 'processing' and that the same would be got implemented soon but in vain. Even, after much procrastination as also as a result of our constant pressures, when ultimately the Final and Modified Restructuring Proposals could be sent from SGO to DST vide No. W-762/709-Cadre Restructure dt. 18-03-2016 as informed to me vide SG's No. J-2416/612-Ministerial dt. 13-04-2016 we did very reasonably urge to include our already-modified proposals and implement the abnormally longpending C.R. in no time right at DST-level itself, thereafter also the vital issue of C.R. Implementation hardly appears to have moved even an inch from the place/position where it was existing earlier. I am, however, constrained to say once again that the Higher-ups(here, DST in particular) cannot and should not have their beyond-limit rights to befool and /or bluff the staff side on the major issue of C.R.Implementation on one hand and thereby knowingly deprive the worstsuffering cadres of their legitimacies well over the decade on the other. And let me remind all concerned that during such long period of 14 years from 2004 to date a sizeably large number of senior employees(staff members) either retired on superannuation or expired being sadly deprived of their promotions/upgradations as an obvious result of non-implementation of the much-awaited & long-cherished. C.R.Truly speaking(which I duly re-iterate also) the simmering discontent coupled with a sizeable degree of upheaval of staffmembers knows no bound.

Anyway, now, without further trying to go into details as to what is what I would simply and categorically request you kindly to intimate me the latest position over the subject issue i.e. C.R.Implementation and the exact possible date/time by which the CR will take place without any further delay by Speed Post Letter under intimation to our Secretary General Shri D.C.R. Karki at DG&RB, SOI, 17, East Canal Road, Dehra Dun-248001(U.Khand). A prompt and positive reply/response is earnestly solicited.Please acknowledge receipt of this very important letter.
