Sir.

At the outset kindly let me heartily congratulate you on behalf of all our members and the Organization M.S.A. being represented by me for long years in the D.C.(JCM) on your having assumed the prestigious charge of the good officers of the Departmental Supremo (though on current-duty basis) albeit for a very short period of only two months ending on 31-08-2017. Needless to say that the new exercise or, say, onus of responsibility of taking charge of this oldest as well as imageful CG Deptt. of heritage like SOI will be of due importance and significance. Let myself and all others reasonably hope that the Departmental Administration as a whole will, henceforth, be running transparently and with all fairness & sanctity. Also needless to say that in this connection we from the staff side will go on rendering our best possible co-operation and services at all times. Hope our Secretary General Shri DCR Karki of G&RB might have, by this time, come across your goodself at your office and had some talks with the Administration.

- 2. I, however, in this opportunity, wish to beseech you kindly to look into the following few important sensitive issues and do the immediate needful as the time at your hand is too short:-
- (i) To interact in and ascertain from the DST as to the real & latest position about the long-overdue CADRE RESTRUCTURING ( since abnormally pending for 14 years) and post me with the same at the earliest. Our Resolution of Ranchi CEC Meeting and the couple of my detailed/important letters to the Hon'ble Secretary to GOI, DST vide Nos. J-MSA/SVY/01 & 09/2017 dt 23-02-17 & 28/09/2017 under intimation to SG & others on the captioned subject "Immediate Implementation of abnormally longpending Cadre Restructuring from its due date right at DST-level itself-Urge for" are referred in this connection.
- (ii) Immediate withdrawal of Technical Hands viz. Officer Surveyors/Surveyors/Asstt. Managers/ ASOs/Others from Ministerial Jobs at various offices of SOI scattered at different parts of the Country and simultaneous filling-up of vacant Ministerial posts viz. E&AO/OS/Assistant/UDC/LDC/Steno at all survey station for smooth & effective ministerial functions.
- (iii) Immediate/earliest reconsideration of the most deserving transfers on promotion from OSs to E&AOs of Km. N. Devamani from Kolkata to Hyderabad and of Shri A.Devadanam from Hyderabad to Hyderabad itself in the three (3) clear & regular vacancies of E&AO lying at Hyderabad since long. Both the cases do merit immediate consideration and the same stands quite well within SG's competencies. My relevant letter to SG vide No. J-MSA/Svy/03/2017 dt.23/02/2017 under intimation to all concerned is submitted herewith for your kind ready reference and immediate favour.
