
Re: Organizational

By this time all of you will have come to know from the Secretary General, MSA's Circular that the next i.e. the 14th A.I.C. of our MSA will be held on 8th & 9th November, 2017 at Jaipur, the Capital City of Rajasthan, falling under the jurisdiction of Rajasthan GDC. Needless to say that necessary organizational & psychological preparations for the AIC will be started by the branches in due course, keeping in view that all branches will attend the AIC and set an all-time record. Very recently(on 17th August, 2017) the Dehra Dun Branch held its AGM and the list of newly-elected office-bearers is stated to have already been sent for all concerned from Dehra Dun.

2 Meanwhile, on request as well as invitation from the host branch i.e. Jaipur I accompanied by another comrade am visiting Jaipur Branch on 3rd & 4th Sept, 2017 for which I'm leaving Kolkata on 1st (night). Secretary General Com. DCR Karki also alongwith some other senior comrade will reach Jaipur on 4th Sept. 2017 morning. We shall decide the venue of AIC and help as well as guide Jaipur comrades in effectively accomplishing all other required tasks meant for AIC. On the 4th midnight we (the four-member team) will start for New Delhi so as to reach there on 5th morning. Our accommodation there has already been booked for 2(two) days i.e. on 5th & 6th upto 4 p.m. as on the same evening i.e. 6th we shall start for Kolkata & Dehra Dun respectively.

3 Our main aims of the operation are two fold ones meaning (i) to reorganize almost defunct Delhi Branch by rejuvenating its activities to the extent as possible including payment of arrear subscriptions & participation in the forthcoming AIC and (ii) to submit a copy each of some important organizational papers /letters to responsible officials, have talks with them and pressurize DS&T for implementing long-overdue Cadre Restructuring based on Final & Modified Proposals already lying with them since pretty long time right at DST -level itself as were done on many other cases/policy matters in the past. I hope our drives (though risky ones) will come to success as far as considered feasible. Please acknowledge receipt of this letter and give wide circulation to the members. Greetings,
