Sub: Immediate Implementation from back date/due date i.e. retrospective effect of the quite unnecessarily long-pending CADRE RESTRUCTURING(i.e. 2nd CADRE REVIEW) – Urge for.

Ref: My last detailed & self-explanatory letter for the DST vide No. J-MSA/Svy./26/2013-14 dt. 19/22-04-2014 urging immediate implementation as also seeking some important information under provisions of R.I.Act, 2005, which was sent by Speed Post as well as through Fax.

Sir,

Kindly refer to the contents of my last detailed-cum self-explanatory letter mentioned under reference above wherein I had reasonably demanded immediate implementation of the Cadre Restructuring Pending since last 11(eleven) years based on our modified proposals submitted to your good office in Sept., 2013 and also wanted to be duly apprised of some information under the provisions of Right to Information Act, 2005. But, as usual, the DST's Office in general and the responsible Deputy Secretary Shri G.Vijay Raghavana in particular have been pleased to choose the same old path of keeping dubiously silent over the sensitive as well as burning policy issue for reasons best known to them only. If the subject"Delaying or Wilful Dilly-dallying" had any kind of National award like 'Padmabhibhusan' or 'Bharatratna' in that case we would have left no stone unturned to strongly recommend the good names of the former Hon'ble Secretary Dr. T.Ramasami on one hand and the recent Dy. Secy. Shri Vijay Raghavana on the other. Some more number of important DST Personalities holding key posts in the Secretariate for pretty long years would have been considered to be duly recommended by us for such National Award. I may be excused for frankly expressing such a bittermost truth.

Neither any action-taken report has been intimated to me within this pretty long period nor any acknowledgement of receipt of a good number of letters/faxes etc. has been sent nor even the information sought for by me under provisions of R.I.Act, 2005 has been sent so far from DST's end. Meanwhile it is unofficially heard that in the 2nd/3rd week of this month the Central Cabinet in its meeting held in presence of the P.M. Dr. Manomohan Singh & the F.M.Shri P.Chidambaram have cleared/okayed the longpending Cadre Restructuring of as many as 3 Union Govt. Departments. It is, therefore, once again urged that the immediate needful action may kindly be taken and the information as asked for by me under R.I.Act. vide my letter mentioned under reference may kindly be intimated to me in no time.
