Holding of AIC at periodical interval particularly in the middle class & educated employees' organisation like ours in SOI (where there are neither agitationl movements nor even any kind of chase/confrontation with Departmental Head & the Government) is almost a routine matter,where lots of points as agenda-items are discussed amongst delegates (sometimes even threadbare), some resolutions are passed, election of officebearers for next term is held and so on and so forth.

Nevertheless, I do congratulate Bangalore Branch and its members on their decision to host our 13th AIC, albeit , I think, it would have been wise to be held at DehraDun for many important organizational reasons particularly during this critical time when the Authorities have almost declared 'war' against the CHQs & the biggest branch by even prohibiting entries of Leaders at SGO from as many as some years back. The 5th AIC was held at DehraDun in 1985 and after this long gap of 29 years this could have been in the fitness of things for DehraDun Branch to conduct AIC in order to help streamline the organizations of CHQs & biggest branch on one hand and repair the severe damages done by SG & his Administration amidst our organizational lapses on the other.
